## 19. Apologies for absence

Cllrs Mrs M Moore; Cllr B Walters

#### 20. Public Session

A resident raised concerns over the proposed development on land at The Coach and Horses public house. He had concerns over the access to the development and also said that would it not be in the interest of the village to delay any decisions until a Neighbourhood Development plan is in place.

Another resident made the following statement:-

"I realise that I cannot ask questions of the Parish Council during this general session, but I would like to respectfully ask, that during your deliberations on Planning, with reference to the Planning Application for the "Coach and Horses" car park, that the following points are clarified.

The application and registration of this Planning Application was after the last Parish Council meeting and submissions concerning this application are due shortly.

The Parish Council website has the closing date of 1st March 2019, but other documents on the East Staffs Planning website indicate 7th March 2019.

Initially, two three bedroom houses seemed to be proposed. However, it is not at all clear what exactly is being proposed.

The submitted, "Planning, design	n and access statement" of January 2019,

4.19 talks of four bedroom units, to quote :- " two off road parking spaces will be provided in each of the attached double garages and one parking space in front of each garage therefore a total of three car parking spaces for each four bed unit."

But, by Section 4.9, it is stated both homes will be "three bedroom/five person homes". However, in the "Heritage Statements" 2.2 "Development proposed include two detached three bedroom dwellings, one three bedroom and one four bedroom.

It is difficult to understand exactly what is being proposed in order to comment".

Mr Wilson, Chair of the Village Hall Trustees commented about the proposal to place a Memorial Bench in the village. He stated that it was considered that maybe the field behind the village hall is not the best place for the bench and other sites need to be considered.

Mr T Wheeldon said that the Clerk has updated on the donations received so far for the War Memorial and this in excess of £2,000 and he asked for an update on where the Parish Council is in terms of the repair.

Public Session closed.

#### 21. Declarations of Interests

Parish Councillors declared an interest in planning applications for Millennium Green and The Nuttery.

# 23. Neighbourhood Development Plan Update

Mr M Hobbs, Chair of the Neighbourhood Development Planning Group, joined the table.

He said that he had a direct question for Cllr P Charles. "Did he have feedback following the meeting that was held between them? If not then it is not right that the group should provide an update."

Cllr P Charles said he was not aware he had agreed to give feedback to Mr Hobbs before the Parish Council meeting.

Mr Hobbs explained he understood that that the Parish Council had no confidence in the NDP Group and that they had agreed to arrange a meeting for members of the Parish Council and NDP Group to meet before today.

Cllr P Charles confirmed he had no recollection of this and of a commitment to arranging the meeting.

Cllr Mrs Appleby said that there seemed to be some confusion about what had been discussed. She asked that this was accepted and that Mr Hobbs moved on to give the NDP report.

Mr Hobbs confirmed that the Neighbourhood Development Planning Group was not willing to provide the report as no confirmation had been given that the Parish Council has confidence in the group.

## 24. HS2 Update

#### HS<sub>2</sub>

- Cllr Jarman provided an update. He said that a meeting had been held with Michael Fabricant MP and that he had confirmed that there is no option to go back to the Rugeley plan. The underground option takes up more land and costs more. Letters currently being sent to landowners to ask for feedback on the underground proposal.
- ESBC will not be petitioning and the County Council has not decided yet.
- In accordance with Section s239 of the Local Government Act 1972 Abbots Bromley Parish Council opposes Additional Provision 2 (AP2) to the High Speed Rail (West Midlands - Crewe) Bill.
   All councillors agreed that the Steering Group should petition against the proposals if landowners agreed to this.
- Cllr Houlihan raised the vunerability of the pylons to a major dam burst and asked if HS2 had done a risk assessment.
- Cllr B Walters to be contacted to ask if he could attend the next HS2 Steering Group meeting instead of Cllr Jarman due to holidays.
- Councillors approved cost of HS2 meetings @ £40 per parish council.

### 25. Matters of Report

#### i. War Memorial

The Clerk provided an update. So far two quotations have been provided for the work to the War Memorial. A further two contractors have been contacted but no feedback received.

Cllr P Ryan provided an update on the Memorial Bench. He said that the design was very nice, however, a better location is needed. Possibility of putting it under the tree on the green looking up to the school. Village Hall Trustees concerned that if it is in that location it may not be clear that it was provided by the village hall.

### ii. Outdoor Gym

Cllr Appleby confirmed that a grant for £10,000 had been received for the new outdoor gym equipment. The preferred locations of the equipment will be presented at the next meeting.

#### iii. Footpath off School House Lane

The Clerk reported that two quotations had now been received and a third was being sourced.

# iv. Village Gateways

Cllr Mrs Appleby confirmed that funding of £1,500 had been received from SCC which needed to be match funded by the Parish Council and an order for some gates placed by the end of March.

The design of the gates was discussed and councillors generally preferred wooden rather than plastic gates of a traditional design. Village Property working group agreed to meet with suppliers and also to discuss possible locations for the gates.

## v. GDPR

The Clerk provided an updated on GDPR and said that she would be providing a briefing at the next meeting and also the new policies for approval.

Councillors discussed comments made in the public session. They confirmed that it is not possible to ask for a delay because the NDP hasn't yet reached consultation stage, if it had then this could be considered.

The planning documents seem to give some conflicting information. The Clerk to ask for clarification on what is being planned.

The Parish Council does not object to the principle of development on the site, however, the gardens are far too small for what will be family homes and shows that the developer is trying to put too much on the site. Rather than 2 detached dwellings, the developer is asked to consider a pair of smaller semi-detached cottages.

In terms of design, simpler finishes are recommended - the use of quoins at the corners is (other than the Coach and Horses PH) not generally representative of development in the villages, and dormer windows should be used more sparingly. The site is within the Conservation Area and the Borough Council are urged to have regard to the current design guidance in the Local Plan.

For safety purposes a footpath should be included in the plans leading from the main street, inside the existing brick wall of the Coach & Horses, giving safe access both to any new properties and existing properties on Radmore Lane.
