117. Apologies for absence

118. Public Session

A member of the public raised concerns over the stiles and gates that had been installed on the public footpaths by Abbots Bromley School. The Clerk updated on the situation and said that a meeting would be held with the school to reach a solution and hopefully have the stiles and gates changed or removed.

119. Co-Option of New Councillors

Several members of the public had attended the meeting with the view to being co-opted on to the council to fill the remaining three vacancies. Each person said a few words about themselves.

Mrs C Spratt – lived in the area for 35 years and used to teach at the prep school. She said she is particularly interested in what does on in the village and with the young people of the village. She does lots of volunteering including working with guide dogs for the blind and would be happy to be considered for one of the vacancies.

Cllr K Baker asked if Mrs Spratt would support the Neighbourhood Plan and would she be willing to support the environment and health objectives of the PC. Mrs Spratt confirmed that she would be happy to support these.

Mr M Lockey – said that he first came to the area in 1968. He has had a professional career as a teacher, an inspector of school and is an ordained priest. He has been in the village for

two years. He has always tried to build bridges with the community and always tries to serve the communities he has lived in. Very much like to be involved in serving the community.

Cllr Baker asked the same questions regarding the Neighbourhood Plan and health and wellbeing. Mr Lockey said that he has helped with Neighbourhood Plans before and is particularly keen on health and wellbeing of the community, in particular addressing loneliness and mental health issues.

Ms R Lynch – Originally from Scotland and moved down to the village about two years ago. She retired last year. Since moving in to the village she has joined the WI and the Choir. She said she would like to find out more about the village and what is happening and who to approach if she needed to raise a complaint.

She confirmed that she would be happy to support of the three PC objectives and is known for speaking her mind.

Mr R Love – said that he is now 46 years old and has lived in the village for 42 years. He has a very deep love of the village and would like to give something back. He went to school in the village and so did his children. He currently coaches football and cricket in the village. He has a desire to support the Parish Council and understands that there are lots of challenges to be faced.

He said he supported the Neighbourhood Plan and believed it was very important as a degree of development is essential and inevitable but needs to be done in a controlled way. He confirmed that he would like to play a role in it. With regard to health and wellbeing he said that everyone is living longer and experiencing greater challenges but he supported the PC's objectives.

It was agreed by councillors to consider co-option of new members at the end of the meeting.

120. Declarations of Interests

Cllr N Taylor-Brown declared an interest in the planning application for Grange Farm.

121. Minutes of Previous Meetings

RESOLVED: that the minutes of meeting held on 25th September 2019 with two amendments.

122. Neighbourhood Development Plan Update

Cllr Baker gave an update on the Neighbourhood Plan.

There have been a couple of meetings with the consultant from Urban Vision. A format for the draft plan has been decided and work is taking place on putting together the various policies. In order to put the policies together there is a need to understand the national and local planning policies and each policy needs to be justified. The consultant has recommended one or two amendments.

The next stage is to prepare the draft plan and invite the community to comment on it – possibly just after Christmas.

Mr Pratt asked what will happen if the 30 acres at the school goes for building. Cllr Baker said that the Neighbourhood Plan will have a policy within it for the school site. He said that the plan can try to influence where development can and can't take place. The principles of the Neighbourhood Plan would not be affected by the school. Cllr Baker confirmed that part of the school's grounds have been included as potential Green Space which should give it similar protection to green belt.

Mr Pratt said that developers will bulldoze through the plan as money talks. Mr Love said that if a sensible plan is put forward then it could be considered if it is consistent with the plan.

Councillors discussed the statement and objectives. Objectives suggested were:-

- To support the Neighbourhood Plan and see it through to completion;
- To support Staffordshire County Council's declaration of an environmental emergency;
- To focus on the health and wellbeing of the whole community

It was suggested that a forth objective for the PC could be suggested by members of the public and this would be asked for via the Bulletin.

RESOLVED: that Cllr Baker would email the mission statement and objectives to councillors prior to the next meeting so that it can be considered at the next meeting

i. Recreation

The Clerk reported that permission for tree works needs be sort soon so that work can be carried out at The Nuttery

ii. Village Property

Bike Racks – it was suggested that the Parish Council should ask the community where they would wish for these to be located if the Parish Council went ahead with them.

RESOLVED: to put an article in the Bulletin asking the question.

iii Traffic, Parking & Highways

Verges in Lanes:- Councillors reported that all lanes are the same although particularly bad on Radmore Lane. Some people are trying to create passing places and eroding the verges. It was suggested that an article should appear in the Bulletin asking people to contact Highways to report damage to the verges.

Mr Pratt asked which part of Radmore Lane was being referred to. He stated that he, along with other businesses, campaigned for the resurfacing of Radmore Lane several years ago. He said that the lane is a main route to those businesses and said that speeding cars are also an issue on the lane. Cllr Dr Whorwood said that he feels that it is important that everyone should be able to use the lane safely, walkers, horse riders, etc. He stated that everyone should be mindful of other users.

Mr Pratt suggested that a letter is sent to all those that use the lane and not just farmers that live down the lane. A resident mentioned that lorry and tractor drivers are more courteous than car drivers. A general discussion on this matter took place. The Clerk mentioned that in other parishes Staffordshire County Council had helped provided additional passing places which may reduce the damage to verges.

School House Lane:- Cllr Baker reported that there is a problem with people parking outside the surgery. This often means that farm, emergency and larger vehicles are not able to pass. Cllr Baker confirmed that he had spoken to the surgery staff and a sign would be put up to advise people not to park on the lane. Cllr Baker said that he is happy to put cones out to stop people parking. The police are supportive of this.

RESOLVED: that Cllr Baker would put comes out to stop people parking. All members in favour.

Mud on Lanes – It was reported that there had been a lot of mud on Woodmill Lane but thanks to go to the farmers for clearing this up.

Pedestrian Crossing – Cllr Baker suggested that a crossing is needed in the centre of the village as there are many children that cross the road to go to school or catch buses along with many residents crossing the road.

RESOLVED: that the Clerk should contact Highways to ask if this may be a possibility in the future.

Vehicle Charging Points – Cllr Baker suggested that it wouldn't do the village any harm to investigate having a village charging point and it may be worth looking at some supply companies.

RESOLVED: to ask the community via the Bulletin if and where one of these could be located.
