Minute 12: Public Session

He believed the effect would be to curtail activities to the point where the farm would be uneconomic.

19.1 Recreation

An additional 2 cubic metres of bark had been added to the surface to address comments made about the depth of fill.

The Clerk reported that repairs to the Butter Cross appeared to be complete although he had received no formal confirmation of this from the County Council.

19.3 Traffic, Parking, Highways

Cllr Fox reported that from the meeting with Richard Rayson, they had learnt that the intention was for kerbing to be installed from the Bennetts to Hoar Cross Road – probably during August. For this the road will remain open but with traffic control. Subsequently the re-surfacing work will require the road to be closed for a week.

Cllr Cook reported that Speed Watch was up and running again with the new gun.

Cllr Cook asked if we could investigate the possibility of speed check warning signs and the Clerk was asked to make enquiries.

Cllr Fox reported on a conversation with Richard Rayson about obstruction caused by anglers parking at the Hoar Cross junction.
