#### Minute 99: Public Session

The Chairman welcomed Mrs Hammersley and invited her to address the meeting.

Mrs Hammersley said she was present to express her concerns about the height of the fence for the proposed redevelopment at the Bagot and drew attention to the close proximity to her property. She had written to the planning officer to put her objections on record. A copy of the letter was provided.

The Chairman thanked her for the contribution, and normal business was resumed at 19:36pm.

# Minute 100: Minutes of previous meeting

RESOLVED that the minutes of the previous meeting on 25 January 2006 be accepted subject to noting that it was CIIr Needham rather than Fox who would be involved in the BKV options, and confirming that there was no paragraph 94.3.

#### Minute 101: Declarations of interest

# Minute 102: Matters arising and matters of report

- 102.1 Circulated documents: No issues.
- **102.2 Distraction burglary:** The materials requested from the Uttoxeter Crime Prevention Panel were now available to be passed on to those in the village who the Council feel would benefit. Members took away copies to distribute.
- **102.3 Police DVD:** Cllr Elkington provided feedback on the "Building Safer Communities" DVD he had reviewed. This seemed to merely outline the political agenda for amalgamation of Police Forces.
- **102.4** Parish Assembly date/venue: Church House is not available for the proposed date, but the Village Hall committee advised that the Players have moved their performances so that there is no longer a clash. The Clerk had subsequently been able to confirm this.
- **102.5 East Staffordshire PCA:** The Chairman reported on attendance by himself and the Clerk at the annual liaison meeting with Staffordshire County Council. Presentations on "Customer First" and "Scrutiny" were followed by lively discussion on highways issues including the need for a review of policy on 20mph limits.
- Ambulance Service: Cllr Esling reported on his attendance at the consultation meeting in Burton, the high level of interest this had generated and strong opinions that were expressed. The Clerk introduced the letter written to the SHA, and response received. He reported that the letter had also been sent to the local papers, Michael Fabricant MP and Janet Dean MP. He noted that the response from the SHA seemed to assume the letter was personal rather than from a community. Agreed that a further letter should be written, clarifying the corporate nature of the response and noting attendance at public meetings.
- **102.7 LocalKids event:** Cllr Needham gave brief report on her attendance at a lunchtime event in Burton. This was arranged to promote a subscription web site giving access to discounts and details of children's activities.

- 447 CU/11242/013: Outbuildings adjacent Bagot Arms: Conversion of stables and outbuildings to form three residential units with associated revised access Received: 09/02/06 Due: 27/02/06 Response: The Parish Council raises no objection in principle to this development, but supports comments made by Mrs Hammersley concerning the boundary fence, access and loss of light. The Council also questions whether the proximity to the Bagot Arms is a suitable environment for domestic accommodation that is not itself part of the licensed premises. If approved, then the Council suggests that a condition be imposed to add foliage screening to the wall and railings to reduce noise and potential for nuisance between the pub and the new dwellings.

## 105.1 Recreation

The Clerk reported that the equipment for Project Playground was expected to arrive at the UK warehouse of the supplier by the end of February.

## 105.2 Village Property

The Clerk advised that an inspection of Council property was now due, and invited a Councillor to join him in the activity. Cllr Elkington offered.

## 105.3 Traffic, Parking, Highways

Cllr Needham reported that she had been contacted by Mr Wright about hedges in Schoolhouse Lane interfering with traffic and this had been reported to Clarence. Mr Wright had also expressed an interest in the nature of safety barriers on the pedestrian exit from the Nuttery.

Cllr Fox reported that Jill Crookes had pointed out the amount of mud that seems to be present on the lower part of Schoolhouse Lane and issues with Narrow Lane. This could also be reported to Clarence for action.

The Clerk provided an update on SCC Highways plans for resurfacing Lichfield Road in the new financial year and for dealing with the continued water-logging of Narrow Lane.

Cllr Fox reported that, as previously noted, the committee would be willing to contribute to the cost of the new tree and/or lights. Clerk to advise Cllr Fox once costs are known. Could some ground improvement in the area of the recycling bins be done to improve ease of access?

- Lichfield and District Council for Voluntary Service is soliciting an update to their database and the Council may wish to consider whether it wishes to be a member. Agreed that membership was not appropriate.
- The Chairman of Staffordshire County Council has invited members of the Parish Council to attend the annual Civic Service in Stafford on Sunday 12 March. None wished to do so although Cllr Fox advised she was already expecting to attend.
