89.3 Correspondence and other planning matters

The Clerk reported that the application for a second wind monitoring mast in Bagot's Park was due to be discussed by the Planning Committee on Monday 21 January. The recommendation of the Planning Officer to the committee will be to "permit".

The Clerk reported that the timetable for adoption of the conservation area appraisal has been put back to March 2008. The document in question was commissioned by the ESBC Conservation Officer, Mr Edwards, shortly before he left. ESBC are now considering reemploying the consultants who did the original work, to take the document through a consultation process that would involve the Parish Council. The Clerk has suggested that they might consider coming to make a short presentation to the Council and has provided the meeting dates for the start of 2008.

The Clerk reported that government has asked all planning authorities to standardise their planning application form and processing – although some local variations are allowed. Consultation documents on this change are now being circulated for comment. He pointed that any response from the Council will require that circulation is completed by the meeting on 30 January so that the proposed feedback can be discussed and agreed at that meeting.
