227.1 Recreation

Youth Shelter – Cllr Waring reported on the Village Hall Management Committee meeting, where he was the only member of the committee who did not object to the siting of the Youth Shelter at the Village Hall. Cllr Mrs Fox spoke on behalf of the Village Hall Committee who referred to the problems with the young people and advice from PC Boulter that they should not be encouraged by the siting of a shelter at the Village Hall.

Cllr Mrs Veitch reported that additional funding of £1,300 has been received towards the Youth Shelter. She went on to say that she felt the council should continue to pursue the provision of a shelter and a number of possible sites were considered. The council discussed the concept of a youth shelter, the problems experienced by the village hall committee and the fact that the youth are part of the village. There is no provision for young people. It works elsewhere why can't it work in Abbots Bromley? **RESOLVED:** to look at all aspects of the MG including the allotment with a view to seeking a site for a shelter and to carry out preliminary enquiries. The design will be largely decided by the final situation – possible top end of MG close to cherry trees. Cllrs Elkington and Mrs Veitch will investigate these points and bring proposals to the January budget meeting

RESOLVED: Cllr Elkington will discuss the matter with Mithra Tonking to keep her informed on progress as a representative of the MG Trustees
