### i. Grass Cutting

The Clerk reported that Mr P Ryan had suggested that the football pitch grass be cut by a local contractor so that it can be cut more frequently to a high standard. **RESOLVED:** that Ollie Crooks would cut the grass at a cost of £15.00 a time and that G McCullouch would remove this area from his contract.

Cllr Mrs Veitch raised the point that the Millennium Green play area grass was still not being cut to high standard and the top area of grass was being strimmed but not removed and that some herbicide treatment was required on the paths. The Clerk agreed to speak to Mr McCullouch about this.

Cllr Mrs Veitch also made the point that the council needed to set aside some money to maintain this play area, the football pitch and the Nuttery and proposed that a budget of £1,000 a year be put aside for general maintenance. If this is not required in a given year then the money should be reserved for the following year.

**RESOLVED:** that the Clerk would include this figure in the annual budget. Proposed Cllr Mrs C Veitch, seconded Cllr R Bell.

# ii Postal Delivery Services

The Clerk reported that there were still concerns by some residents over late delivery of post with some not receiving their post until 4.00pm.

#### iii Post Office

The letter notified customers that a consultation period had now started and contact could be made during this period to give support or raise concerns over the proposals.
