55. Apologies for absence

56. Public session

Cllr R S V Jarman declared the public session open.

Mr T Wheeldon gave a report on the incident that took place outside of his house in which a tractor and Peugeot car collided also damaging his car. In his opinion if the tractor driver had been taking due care and attention and driving according to the road conditions then the amount of damaged that occurred would not have happened. He reiterated the potential seriousness of this incident and what could have happened at a different time of day when children would have been walking home from school or the school bus.

He asked what could be done to stop this in the future.

Mr D Eatough asked when will the Highways Department do something to resolve the traffic issue in the village. There seem to be far more lorries and tractors using the village, all driving at a greater speed and not driving according to the road conditions. He personally had noticed cracks in his walls which he believed were due

to the HGVs using the village. He felt that there was a complete lack of County Council Action.

Mr J Hayley asked when will the white lines be put in place at the Goose Lane junction. These had been mentioned in a previous Bulletin and had not yet happened. He has witnesses many near misses due to parked cars being too near to the junction.

The Clerk explained that these had been blocked by the Highways Department and work was still on-going to try and get these put in place.

PCSO Jo Bradley offered support for all the Parish Council plans and would continue to warn or ticket people who persist in parking at this junction.

Andy Mason, ESBC informed the meeting of the work that was currently taking place by Neighbourhood Forums and how these would work to improve local communities, including traffic issues. He mentioned how he was already in discussions with farming groups about the tractor driving safety in villages and this was issue he was currently addressing. Mr T Wheeldon volunteered to join the Neighbourhood Forum.

Tom Wheeldon highlighted that the road classification may be correct but this level of traffic can not continue through the village.

CIIr R S V Jarman informed the meeting that another date would be scheduled to discuss the proposed Wind Farm at Bagots Park. He asked that all those that would like to attend the meeting should leave their telephone numbers so that the Clerk could inform them of the date for the meeting.

The public session was closed and the meeting re-opened.

P/2010/00794/EW: Dolphin Cottage, High Street, Abbots Bromley, Staffordshire, WS15 3BN: Erection of three detached dwellings and one pair of semi-detached dwellings (amended description)

The Parish Council response is:

The Parish Council objects to this development on the following grounds:-

1. Parking:-

The reduction from 6 dwellings to 5 will still not resolve the issue of insufficient parking as the two remaining semi-detached houses have now increased in bedroom size and may as a result require additional parking. The properties will also be larger properties than originally planned and therefore will free up very little space for parking. There is also the question of parking required for Dolphin House itself, will residents have parking allocated on this development or will they be expected to park on the main road which is already heavily congested?

2. Access:-

In our previous objections we highlighted how unsuitable the access to this development is. These objections still stand. The access is almost blind when pulling out and vehicles have to edge out on to the pavement in order to see and even then visibility either way is very restricted. This pavement is a busy pedestrian route, particularly in the morning and afternoons when children and walking to and from school and the bus stop. The drive is also too narrow to allow large vehicles to enter without having to crossover the highway to swing in or to reverse up. Many larger vehicles eg refuse lorries or fire engines would not be able to use this access at all.

As in our previous emails we would request that the planning department does visit the site during term time either in the morning or mid afternoon to access the situation.
