i. Insurance Renewel

The clerk reported that the insurance cover had been put out to tender this year and three quotations had been sourced. These were from AON the current insurer, Came & Company and Zurich. All quotations had been based on the previous year's assets plus the addition of the new village benches. Quotations received were as follows:-

AON - £1,777 per annum

Zurich – £1,319 per annum

Came & Company - £1,358 (16 months for the first year and then 12 months thereafter. The price for Came & Company was based on a 5% discount if the agreement was for a minimum of 3 years.

RESOLVED: that the council would terminate the insurance policy with AON and accept the offer from Came & Company. The decision being based on the offer for 16 months cover instead of 12 for the first period.
