ii. Budget 2011/12

The Clerk presented the proposed budget for 2012/13 and this was discussed by the councillors. The Clerk highlighted that the budget included a small rise in the precept from £20,700 to £21,150. Based on this year's base tax rate this increase in the precept would not increase payments by individual households in the band D category. She also highlighted that spend for next year would exceed income, however, this was due to the Parish Council's current surplus being allocated to specific projects and to ensure that moving forward the council had just 3 months running costs as surplus.

RESOLVED: that the council accept the budget for 2012/13 proposed by Cllr Mrs D Burrows, seconded by Cllr Mrs M Moore. All members voted in favour.
