34. Public session

Mr S Wilson updated the Parish Council on plans for the Jubilee. He said that he was involved in organising a go-cart race for under 16's and over 16's which would take place on several roads in and around the village. He had been in touch with ESBC and would be requesting permission for road closures while these races were running. He also reported that the Village Hall would be holding an afternoon tea on the Bank Holiday Monday to celebrate the Jubilee.

Mr Wilson went on to ask if he could access some funding towards the organising of the go-cart race and also some bunting. The clerk confirmed that this had been noted and a decision on allocation of donations would be agreed at the next Parish Council meeting.

Mr Wilson also commented on the recent article in the Bulletin regarding being neighbourly in which he assumed that the mention of 'the severe laying of a hedge' referred to the work on the hedge by the Village Hall. He confirmed that he had been in verbal correspondence with ESBC and they had confirmed no wrong doing. He did say that the residents should probably should have been notified beforehand, however, it is still the desire to do all of the hedge.
