48. Public session

51. Matters of Report

i. Village Planters

The village planters were discussed. The clerk explained that she had been in touch with the company that supplied the previous year's and they did not do a taller tub. They could provide sign mounted tubs but these would be too wide.

RESOLVED: to request that the same planters as the previous year would be used but that these be built up off the ground. The clerk to request a cost for this and also request that that flowers be in red, white and blue.

ii. Village Mini Bus

The Village Mini bus was discussed at length. Cllr Jarman explained the process for booking the mini bus that the donation of £150.00 had been mentioned in the terms for booking in order to help cover running costs for the bus. He also recommended that the booking form should also include the signature of the bus manager when the driver's license had been checked.

Cllr K Johns questioned why the Youth Club had not been involved in the mini bus management as they had been involved in raising some of the money. She felt that the process had been badly managed.

Cllr M Moore requested clarification on the background to the mini bus project and if the purpose of the discussion was to go back with feedback on the booking form and booking rules and regulations.

Cllr R Mills expressed concern over the booking rules and regulations and booking form and stressed that the Parish Council needed to ensure that the booking system was fully checked by a legal team.

RESOLVED: that the clerk should go back to the Scout and Guide Group with amendments required to the forms. The legal services of the SPCA or SLCC should be then used to check the contracts and forms.
