5. Lengthman's Contract

The clerk reported that the tender had been advertised on the village noticeboards and website since 30th November. As only three contractors had requested information on the tender the clerk then contacted a further two companies and forwarded tender information to them.

By the end of December only one envelope containing a tender had been received so the clerk then contacted others that had requested information to ascertain interest. Two of these contactors informed the clerk that they did not wish to tender and the other two companies did not return responses in time although their details have been kept for future reference. The Members debated whether to extend the tender further, however, as tenderers had been contacted it was agreed that it was acceptable to consider just the one tender. On evaluating the tender of Mr G McCulloch it was agreed to award him the contract as the service and quality of his work had always been of a high standard. The price quoted by Mr McCulloch was within budget with only a small increase of £5/day on the present rate. Mr McCulloch's insurance and health & safety documents were also checked to ensure that they met the required standard.

RESOLVED: that the clerk would contact Mr McCulloch and inform him that he had been awarded the contract until October 2015.
