He confirmed that the application had been refused along with 2 other wind turbine applications on the same day. He continued to say that it is most likely that the applicant will take this to appeal.

## **Applications**

**809 - P/2012/01478: Harts Farm, Radmore Lane, Abbots Bromley, Staffs, WS15 3AP** Installation of a 37 metre high wind turbine Received: 22/11/12 Replied: 01/02/13

The Parish Council objects to this revised application on the following grounds:-The height of 36.8 m is from the hub to the foundations. To the blade tip (which will be very visible) it is in fact 48.5 m. Given the prominent location of this structure as well it will be highly visible from miles around. The survey re bats and herons appears to be incomplete because it was not taken at the most relevant time of the year.. Distance from all surrounding dwellings is not clearly stated. SCC are one of many councils considering an "exclusion zone" to dwellings of up to 2km. Although this exclusion zone is not yet in place we are aware of many properties in close proximity that will be affected by the noise. If the turbine is being installed mainly to produce electricity to the farm, with the surplus being sold off. The Parish Council would question why it needs to be so large? If this application is passed it will set a precedent and could open the flood gates for future applications which would have a dramatic effect on the landscape. At a recent a resent Parish Council meeting the council received 5 letters of objection to this application and one resident attended the meeting to reinforce his objections. The Parish Council has also received correspondence from neighbours of the applicant that have not been consulted despite being in close proximity. It has also been brought to the council's attention that most of the neighbours did not receive notice of consultation for the first application in November and have only recently been made aware of this.
