# 87. The Village Plan

Ms A Millett provided an updated on the local plan. She explained that Abbots Bromley is currently classed as a Tier 2 village and as such has an allocation of 40 new homes. She explained that it is important for villages to have some growth. ESBC would like the Parish Council to consider where they feel the growth should be. ESBC produce a SHLAA assessment for each potential site. It was agreed that these SHLAA assessments would be sent to the Parish Council. Ms Millett said that the 40 house allocation would include any that have been given planning permissions since April 2012. ESBC would also provide details on the properties that have been given permission since April 2012. Members were provided with map detailing the plots that had been identified as potential sites for development for members to consider. Feedback to ESBC would ideally be by the end of July so that this can be included within the local plan ready for publication in October.

### 88. Recreational Facilities

Cllr Hall provided an update on progress with Gallimore's Field.

At present he said that there were two options to try to progress with Gallimore's Field. Option 1 would be to make the offer of £50,000 as the majority of this funding had now been found. Option 2 would be to facilitate the moving of the development boundary to allow for two houses to be built with the aim for the village to be given the rest of the field for free. The matter was discussed by members and all agreed that the Parish Council would continue to support the Friends of Gallimore's Field and the Village Hall and however they wish to progress. Cllr Hall and Mrs Veitch said that there would be an open public meeting held by the Friend of Gallimore's Field to consult with all those involved or affected by the project.
