133. Apologies for absence

137. Matters of Report

i.. Field Behind the Village Hall

Cllr Ryan provided an update. He confirmed that the solicitors are still awaiting signatures of Section 106 although he does not envisage any problems. He confirmed that a letter would be going out on 31st October to all 47 homes that had donated money. Cllr Ryan also stated that any monies that were not returned would be used to help develop the field including a new access, a hard surface pathway and a separate entrance to the village hall.

ii. Neighbourhood Development Fund

Cllr Ryan confirmed that the Village Hall Committee would be putting in an application to the Neighbourhood Development Fund to help aid work with the field and proposed improvements. A representative from the Committee would be attending the meeting on 19th November 2013.

The Clerk confirmed that S Botham from ESBC had confirmed that the Parish Council could also claim match funding for work to maintain the footpaths.

RESOLVED: members approved application for match funding providing it was made clear that the match funding would come from funds received from Staffordshire County Council Highways devolved maintenance. Cllr Mrs Moore also confirmed that she would attend the meeting on 19th November 2013.

iii. Staffordshire County Council Update - Cllr Atkins

Cllr Jarman read out a letter from Mr Tim Coates regarding work undertaken at the Cross O Hands.

Cllr Atkins provided an updated on the County Council and confirmed that he is still leader of the council. He said that the council is presently undertaking many consultations and that they are directing funds where it is really needed. He said that the county currently has an unemployment level of 2.1% and 8,600 new jobs have recently been created. He said that there are a lot of people in the county requiring care.

Cllr Jarman raised concern over the state of the roads in the village and how long many repairs have been outstanding. Main concerns were raised over Goose Lane, Radmore and the lane by Dunstall Hall Farm. Cllr Atkins said that the crews were flat out trying to do repairs but these had to be prioritised. The matter was discussed at some length with several councillors raising concerns, particularly over the condition of Goose Lane which is now becoming unusable due to regular flooding and deep pot holes.

Cllr Atkins said that he would ask Chris Mitchell from SCC Highways to arrange a meeting with the Parish Council and visit the areas of concern. He said he would also take a drive around the area and have a look at the areas of concern.

Cllr Jarman asked if it would be possible to have the 20 is Plenty scheme back in the village and to also extend the signage to incorporate the girl's school as it had been noted that the signs are currently located outside the school at Bishton which is a private school. Cllr Atkins confirmed that the rules had now changed on the scheme and it may now be possible to extend the signage. Cllr Atkins said that he would request that the village was added to the list again.

Cllr Atkins confirmed that the County Council voted against HS2 and that there is no economic advantage for Staffordshire. He said that the County Council would need to petition government. 1800 homes are affected directly in the county but so many more will be affected by all the work that will be undertaken. The council is trying to ensure that the voices of the people are heard and is putting money up to petition parliament.
