i. Wild Flower Planting

ii. Parish Surgery

Two matters were raised at the surgery, firstly the condition of the footpath that goes from School House Lane to the back of the Village Hall as this is now often muddy and would benefit from a hard surface. Secondly there still seems to be some owners that are allowing their dogs to foul on Woodmill Lane. Cllr Mrs M Moore agreed to attend the next surgery in May.

iii. Report on Highways Presentation

Cllr Jarman reported that he had attended a presentation by the Highways Department and confirmed that he had circulated the presentation to all councillors. Cllr Jarman said that he was very disappointed with the presentations given and that really the Highways Department had little interest in undertaking repairs to minor roads. The main focus now seems to be on A roads and on the upgrades to the A50. Cllr Hall suggested that the more people that report a road defect the more likely it is to be considered for repair. Reports should be made via the link on the County Council website.

iv. Mini Bus

The Clerk reported that the contract for the gifting of the mini bus had been sent to a solicitor for input.

v. The Bagot Arms

Mr D Cowell from the Bagot Arms informed councillors that he had recently been informed that the Bagot Arms had been sold by the brewery and the new owners may look to turn the property in to a retail outlet or possibly living accommodation. He explained that the only way to avoid this is to try to get the property listed as an asset to the community. Cllr Jarman and Cllr Hall explained to the councillors how the process works. Mr Cowell said that Newborough Parish Council had recently put in an application to support The Red Lion and this had been successful and the pub had now been taken over by new owners. He asked if the Parish Council would be willing to submit an application to support the Bagots. Cllr Jarman said that the council had three options; to be involved, not be involved or to seek more information before the next meeting.
