22. Presentation on Conservation Area Review

A presentation on the ESBC Conservation Area Review was given by Mr Ben Williscroft.

23. Public Session

Following on from the presentation from Mr Williscroft members of the public asked questions:-

Mr Baker asked why amendments to the Conservation Area boundary were not being considered.

Mr Williscroft responded and said that the review is an opportunity to study the conservation area and ensure it is fit for purpose and it may be that properties or areas have been left out or included when not necessarily appropriate. For extensions of the boundary there does need to be a sound historical reason.

Cllr Jarman recommended that names of owners of properties are removed from the document as these go out of date. Mr Williscroft explained that this can only be

- changed by English Heritage and tends to be done through comprehensive reviews but these are only done every couple of decades.
- Cllr Ryan said that he was surprised that some buildings were not listed given the type of building and location.
- Mr Male said there may be some pressure to extend the boundary due to development threats. He also commented that signage is an issue and the Highways department are behaving like legal vandals.
- Mr Williscroft explained that there may be a need for a management plan.
- Mr Male asked who is going to be taking action and what is the timescale.
- Mr Williscroft explained that everyone is responsible for the conservation area; ESBC, SCC, PC and residents.
- It was mentioned that Article 4 takes away permitted development rights, it is similar to listings but for the external of buildings. Maybe some buildings are appropriate for Article 4.
- Mr Male asked who would take it forward. Mr Williscroft said that this would be ESBC.
- Mr Baker talked about the medieval village. He asked if ESBC would be supportive if there is a recommendation to extend the boundary if these were of historical interest. He stated that the conservation area would not stop properties being built but it could give a watching brief on how and where the buildings are built.
- Cllr Ryan said that he had noted that there was a medieval sheep pen on the corner of Yeatsall Lane and Goose Lane.
- Mrs Evans reported pot holes on Moor's Lane. The Clerk agreed to report these but suggested that the more people that report them the more likely that they would be repaired.
- Mr Baker commented regarding dog mess and asked if the PC could now write a strong letter to the enforcement team to ask them to come to the village. He also commented that the PCSO had still not done anything regarding parking on pavements. He asked if the PC could exert pressure regarding both matters.
- Mr Male mentioned two documents that had published about traffic management in villages.

 Cllr Jarman asked if Mr Male could let the PC have details of the documents so that it could be included on the next agenda.
