136. Apologies for absence

Cllrs P Greenwood

137. Public Session

Mr P Male from Lichfield Road asked about the Highways Group that he had suggested earlier in the year and whether any progress had been made in forming one. Cllr Jarman said that no progress had yet been made but it would be revisited, most probably as part of the Neighbourhood Planning process.

Mr D Cotton, Paget Rise said that he would like to raise his objections to planning application P/2015/00822, the turkey shed off Harley Lane. He said that the building will be highly visible, there will be increased traffic on a single track road. The application for a building to house 800 turkeys would also cause problems with smell, removal of waste, increase in vermin and the noise from 800 turkeys would be intolerable. Access to the building will be via Gapstile so drivers will have to drive 150 metres up a field to the building. This building would have a negative effect on the value of properties in the area.

Mr C Bevan said he would like to echo the comments made by Mr Cotton.

Mr J Cartwright of Hobb Lane, Marchington Woodlands raised his concerns about the proposal of the turkey farm on Hobb Lane, 2 x 100 metre sheds. He said that the development would change the character of the area. The applicant says it is an extension of the farm but all they are farming in this area is arable.

He continued, it is estimated 2.5 HGVs per week, this is misleading as it will peak and trough and could be 10-15 per day at peak times. The access is via a single track road that is not even used by bin lorries or school buses. Whichever way you leave the site the road is not suitable and if exiting on to the B5013 this is a very hazardous turn. The roads also have soft verges and the tarmac may well cave in at the sides of the road.

The applicant says that a smell survey has been carried out and that the smells emitted from the sheds will be below EU regulations but this does not address the manure that will be spread on the fields on left in piles outside the sheds.

A resident of High Trees Farm said that he had spoken to ESBC and environmental and they seem to be taking the application in context and seem happy with it. He said that he was genuinely concerned about the environment.

Another resident said that the watercourse feeds into the Blithfield Reservoir.

Cllr R Robb said that she would recommend refusal to ESBC, this was seconded by Cllr Walters. Cllr Jarman urged everyone to write and make a formal complaint.

138. Declarations of Interests

Cllr Mrs R Robb declared an interest in the planning application for a Turkey shed off Harley Lane.

139. Minutes of Previous Meetings

RESOLVED: that the minutes of meeting held on 28th October 2015 be approved.

140. Matters of Report

i. Neighbourhood Development Fund

Update provided. It was confirmed that both the cycle racks and footpath kissing gates would be considered for the NDF. Cllr Ryan said that funding may not be required for the kissing gates if SCC fund these. Contact needs to be made with the farmer to see if they would agree to the replacement of the existing stiles with kissing gates.

RESOLVED: The Clerk to make contact with the farmer.

ii. Library Services

Mrs Catherine Mann from Staffordshire County Council provided an update on the library services for the village. She confirmed that following the consultation the library services would be reduced to one stop in the village at the Bagot Arms. This would be there from 3.15pm to 4.45pm, a 90 minute stop in total. Cllr Jarman said that the Parish Council was not consulted properly on this. Mrs Mann confirmed that the email had been sent to the wrong email address. She said that 1054 people had responded to the consultation which is a ¼ of active library borrowers. Cllr Walters asked how figures were calculated and asked if it is just worked out on the transactions or number who visited the library. Mrs Mann said that it was calculated on the number of visitors.

iii. Parish Surgery

Cllr A Wakefield attended the Parish Surgery. Concerns raised over street parking.

iv. Traffic Collision outside Ivy Manor

PC Boulter explained that the collision occurred as a vehicle was travelling down the village. Vehicle exiting the building side may have been a bit eager to exit the site and clipped the back end of the car that was travelling down the street. This car then hit two other vehicles. It was not considered that speed was a factor. Cllr Jarman said that he had visited the site and the Foreman had said that the cars were allowed to park on the road and wasn't particularly co-operative.

v. Consultation on the future management of the Staffordshire's Countryside Parks and Green Spaces.

The Clerk brought this consultation to the attention of the Councillors and asked for any

vi. War Memorial

Repairs to the posts and fencing around the War Memorial were discussed. It was mentioned that the oak posts are now rotten so will need replacing. The Clerk mentioned that Staffordshire County Council Highways would need to be consulted to find out what materials could be used to replace the posts.

RESOLVED: that the budget should be allowed for this when preparing the 2016-17 budget.
