964 - P/2015/01454: Land South of Hobb Lane, Marchington Woodlands, Staffordshire, ST14 8RG Erection of 2 agricultural buildings for poultry production with associated infrastructure including feed bins, hardstanding and drainage attenuation pond

Received: 04/11/15 Replied: 27/11/15 Response: The Parish Council strongly objects to this application for the following reasons - The appropriateness of such a development in open countryside - Safety & other issues arising from increased HGV traffic - Smell arising from the development & proposed method of managing manure The area proposed for the development is open-aspect arable farmland backed by woodland. Despite the proposal's claim that the development would be screened, we feel that the Turkey buildings & associated plant would be visible from Hobb Lane, from the Staffordshire Way public footpath & from nearby residential properties. It would significantly change the character of the immediate area. Hobb Lane and the exits either way are not suitable for large articulated vehicles. Hobb Lane is a narrow lane with sharp bends and high hedges. Movement of large vehicles on this road would cause significant dangers for other road users including those in vehicles, on foot and on horseback. There are also very few passing places and soft verges which would be significantly damaged by such vehicles. When leaving the site vehicles would need to either go via the B5013 or through Marchington Woodlands and Marchington. The junction on the B5013 has seen many accidents in this area over the years and some have been fatal. Any additional large vehicles entering this road would be an accident waiting to happen. The route through Marchington has some very narrow sections and a significant number of blind bends and blind summits and would present even more risk of accident & road damage. The proposal states that the manure produced by the operation would be spread on surrounding fields. It includes an 'Odour Impact Survey' which claims the smell emanating from the turkey buildings themselves would be below the EU threshold. This does not take in to consideration for the tonnes of Turkey manure that will have to be stored outside for up to 6 months and ultimately spread onto surrounding fields.

Received: 06/11/15 Replied: 27/11/15 Response: The Parish Council objects to this application for the following reasons - The appropriateness of such a development so close to residential properties - Unsuitable access via a farm track - Smell arising from the waste created by the turkeys and increased risk of vermin The proposed siting of the building will be close to many residential buildings and therefore many of these residents will be impacted by the noise and smell created by up to 800 turkeys. Turkeys are known to react to noise and with a footpath running along the track the birds will be disturbed regularly and therefore generate significant noise. With poultry and their waste comes an increase in vermin which again will impact on the quality of life of local residents. As the turkeys will be free range much of their waste will be on the field and therefore the smell will travel to local residents' houses. Access to the site is via Harley Lane and then a single track, unsurfaced road. Neither road is suitable for large vehicles that will be used to transport turkeys to and from the site. To summarise the development will have a significant negative impact on many of Abbots Bromley's residents.
