78. Apologies for absence

79. Public Session

Mrs Appleby mentioned Ashbrook Lane and asked who should speak on behalf of the residents. Should several speak or should residents nominate people to speak.

Mr Brister asked if previous comments were taken in to consideration.

Cllr Hall confirmed that no timetable had yet been set for the appeal hearing but all previous comments would be taken in to consideration. He said it is most likely that the hearing will take place in Burton-on-Trent and may not be until January. When the hearing opens the inspector will generally ask who wants to speak and what they want to speak about. He said that at a recent hearing two representatives of "Save Our Stretton" were allowed at the main table and cross examined under Rule 6. This would mean an opportunity for one or two people to represent everyone else. He confirmed that the local authority will be defending the appeal and in Cllr Hall's opinion this appeal shouldn't be happening.

Mr Wheeldon said that he had already submitted his comments and said that he had also mentioned the Neighbourhood Plan Group that has already been put in place. Cllr Walters confirmed that the Neighbourhood Housing Survey will have taken place by the time the hearing takes place.

Mrs Mills asked if the inspectors visit the site. Cllr Hall confirmed that this would happen.

A question was asked as to whether it would be better if ten people spoke on separate points or one or two people speak about the key points.

Mr Brister said that the sheep have been removed and could this be the farmer's attempt to make the land look fallow. Cllr Hall said this could be mentioned in a resubmission.

It was also mentioned by a resident that a young lady was seen in the field a few weeks ago and seemed to be examining plants and carrying out research.

Cllr Charles said that at this time of year the sheep are usually taken off the land and then the field is cut for sileage.

Another resident said that he had recently spoken to some men in the field on the other side of Askbrook Lane and they were from Taylor Wimpey. They said that they were the owners of that land.

Mr Male said that he had recently visited the doctor's surgery and found out that the physiotherapy treatment would no longer be available at the surgery. Mr Male then commented on when the minutes are made available on the website and asked if these could be published at the same time as they are made available to the councillors. The Clerk said that they are published at the same time as they are made available to councillors but in June the person that manages the website was on holiday and therefore there was a slight delay in posting the papers. This had already been clarified with Mr Male via email before the meeting. Mr Male also mentioned the email he had forwarded to the Parish Council about the footpath/footway on Lichfield Road and who would be responsible for the maintenance of this. Cllr Hall said that this issue had already been raised by Mr Male with him and asked if he still wanted him to deal with it or for the Parish Council to take it on. The Chair confirmed that this will be discussed later in the meeting.

Mr Wheeldon said that people would be convening at the War Memorial to commemorate the Battle of the Somme.at 7.15-7.30am on Friday, 1st July.
