iii. Neighbourhood Plan Update

Cllr Walters reported on the recent surveys carried out by the Neighbourhood Plan Group.

Highways:-

The village very concerned about the issue. Although the Neighbourhood Plan cannot directly address this issue it could help with plans for the future. For example removal or not replacing white lines on roads as this may help reduce speed by showing people that they are using a shared space.

Housing:-

Assessment process completed. Twelve categories used to assess the SHLAA sites but didn't take any of them forward. The group drew up a list of eight additional sites adjoining or just out of the settlement area. All sites have been accessed and marked against criteria. Two sites that scored highly were Site 8, Bagots View, which book ends Bagots View, also Anglesey Playing Field at the school. The school wants to sell off the land for development. The school will be removing equestrian facility from the site and offering it elsewhere in the Parish. There is the potential for a housing mix on the school site and great community gain. Potentially the site could provide a new location for the village doctor's surgery.

The Neighbourhood Planning Group is in a strong position as this is the only mechanism that would enable development and would give a lot of control over what is on the site.

Cllr Charles raised concerns over the access to this site via Radmore Lane as it is little more than a single track road.

RESOLVED: that the Parish Council is happy for the process to proceed. All members in agreement.

Cllr Walters reported that full results of the surveys would be reported at the village meeting to be held on 15th March at the Village Hall.
