36. **Public Session**

Mr T Wheeldon presented two cheques to the Parish Council to include in the funds for the repair works for the War Memorial. Donations received from Mr Sid Slater (£287.00) and The Cricket Club (£100). Letters of thanks to be sent to both.

Mr Wheeldon updated on repairs to the War Memorial. He said that there are three possible ways of solving the drainage problem, two involving inclusion of gullies and one using permeable tarmac. The methods using gullies could raise issues as the joints may leak. Permeable tarmac seemed to be the preferred method. Councillors asked if more research could be done in to usage of other stone sets instead of tarmac as these may be more sympathetic in the conservation area. Mr Wheeldon said that he would undertake further investigation.

PCSO Bradbury joined the meeting and introduced himself. Cllr Mrs Moore said that the main concerns raised in the village are speeding and parking. PCSO Bradbury advised that any concerns should be called in via 101 and also asked if Community Speed Watch had been considered. This was discussed and it was agreed to ask for volunteers again to see any were willing to come forward to start up the scheme again. PCSO Bradbury willing to help with set up. He also confirmed that he could help with access to the police speed van in the area. Smart Alert details also handed out.
