82. Matters of Report

i. War Memorial

The Clerk provided an update on progress so far with the repairs to the War Memorial. She confirmed that contact had been made with Highways Department and she was awaiting a meeting so that removal of lights could be discussed. This needed to be done before contractors could be briefed on groundwork to be carried out. Meeting to take place after 14th July as contact from Highways is on annual leave.

ii. Horn Dance Leaflet

The Clerk confirmed that the Horn Dance leaflet is progressing and all images should be completed by mid-July with layout by the end of July. Printing will take place early August so that it is ready in time for Horn Dance.

iii. Goat's Head

Cllr Walters said that contact had been made by the new tenants of the Goat's Head and they would be willing to re-open the toilets located at the Goat for village use and would install new gates so that the entrance to the pub beer garden could be kept closed with access still available to the toilets throughout the day. Cllr Walters said that there had been many requests from residents for village toilets and that this would be a positive step. The matter was discussed and all members agreed that Cllr Walters should follow this up with the tenants. Consideration needs to be given for on-going maintenance and cleaning as there would most likely be a cost to the Parish Council.

85. Group Reports

i. Recreation

Cllr John Houlihan reported that he, along with the help of the neighbours, Steve Coxon and Don Barker had managed to power wash off all of the bird droppings. He also reported that at his recent inspection he had found graffiti on all of the play equipment. Cllr Houlihan asked if thanks could be sent to both Steve and Don for their help with washing down the playground. The Clerk said that she had removed some of the graffiti with nail varnish remover and then Steve Coxon and Cllr Walters had both carried out further cleaning and it had now all been removed.

It was agreed that it may not be a major problem in the future and hopefully is a one-off. The Clerk asked if it was worth putting a sign on the gateway to remind people that the playground is for young children and these should be accompanied by an adult.

The Clerk also reported she had been in touch with Cllr Hall and he had confirmed that he would be able to provide a grant of £500 towards repairs and painting of the playground. **RESOLVED:** that the Clerk should apply for the grant from Cllr Hall and also contact Mr Bradbury to carry out painting work after the school holidays.

Cllr Jarman and Cllr Houlihan reported that they had attended a meeting with consultants that are working with ESBC regarding recreation and open spaces. They felt that it may be more beneficial for them to meet with ABSA.

RESOLVED: that the consultant's details be passed on to ABSA

ii. Village Property

Cllr Mrs Appleby reported that the bin by the Ruchi was damaged. Councillors also mentioned that several of the bins in the village don't seem to have been emptied recently and were overflowing.

RESOLVED: that the Clerk would contact ESBC regarding this.

iii. Traffic, Parking & Highways

Councillors raised concerns over the traffic congestion and illegal parking of vehicles blocking the pavements by Abbots Bromley School. The Clerk reported that she had emailed the Bursar at the school but he had not come back with a meeting date. She had also emailed the managing director of ASD Developments but he had not responded and she had sent images of illegal parking to the PCSO and had not received a response either. Cllr Jarman said that he still felt that the school should help resolve the issue as they had profited from the sale of the properties for development.

RESOLVED: that the Clerk would ask the PCSO to visit the area when they are also visiting the Crown car park to check on parking during school drop off.

Councillors also reported that there are still several pot holes that haven't been filled including ones on Ashbrook Lane/Lichfield Road junction, around the corner on Ashbrook Lane/road to Hoar Cross, Old Lichfield Road

RESOLVED: that the Clerk should report these again to Highways.

Staffordshire Ironman was raised. Event went off without too many problems. It was noted that road closure signs weren't clear on the day and weren't removed quickly once the event was over so some people still thought the road was closed. It was thought that there may be some issues with plastic bottles left in the ditch on B5013 but it would be hard to tell until the grass and hedge had been cut.

.iv. Competitions

Cllr Mrs Appleby reported that we should be getting a third visit from judges in July. She is going to visit the clubs that have helped out and thank them as well as provide certificates for the children. Next year she would also like to encourage pubs to become more involved in the competition. Book vouchers to be purchased for winners of the poster competition and presented by Cllr Appleby.

Cllr Appleby reported that the Church Yard is still a mess, despite the fact that concerns have been raised about this.

RESOLVED: that a representative from the Parish Council should attend a meeting of the ABPCC to stress that the Council is not happy with the quality of the mowing and that the grant given by the Council may be reduced or removed.
