105. Apologies for absence

106. Public Session

Mr T Wheeldon spoke about the Remembrance Parade and said that he will continue to organise it as he has done in previous years. He wanted to know if people that attended the parade, other than those from the British Legion, would be insured. He said that members of the Legion would be covered.

Cllr Mrs A Wakefield stated it would be difficult to gain insurance, what would the insurance be for and what would be covered? There is no staging provided or extra barriers so difficult to ascertain what insurance would be needed for.

Cllr Mr P Ryan asked what guidelines had been received from the British Legion. Mr Wheeldon said that he had asked the Legion and they had advised that their members would be covered but the general public are not.

Further discussion took place. Borough Cllr Greg Hall confirmed that Yoxall is continuing as in previous years, Burton and Uttoxeter events are both covered as they are organised by the councils.

Mr Wheeldon said he would continue as before but would do some further investigation.

Mr Wheeldon also handed over £20 donation from a resident for repairs to the War Memorial.

108. Minutes of Previous Meetings

RESOLVED: that the minutes of meetings held on 26th July be approved with two amendments.

109. Matters of Report

i. War Memorial/Remembrance Parade

The Clerk reported that she was still awaiting feedback from Highways regarding Highways boundary and replacement of the lighting. Parade discussed earlier in the public session.

ii. Horn Dance

The Clerk reported that the Horn Dance stalls had raised £155.00 but still waiting for the donation from the Ice Cream van. Generally a poor day of trading for the stalls due to the bad weather.

iii. Goat's Head

Cllr Hall provided an update on the Goat's Head. The pub is still owned by Punch/Heineken. The owners have submitted plans for the remaining renovation work which do not meet the requirements of either ESBC or English Heritage and therefore more work had to be done on the plans being submitted. Cllr Wakefield asked if ESBC could not enforce the owners to meet the requirements and move forward with the work so that the pub does not fall in to further disrepair. Cllr Hall said that he was going to contact Heineken. In the meantime it was reported that Rose from the Coach & Horses would be re-opening the Goat while a new tenant is sought.

iv. Parish Surgery

Cllr Mrs R Robb attended the Parish Surgery. She said that the surgery was attended by Mr and Mrs Fleeman and also Mr Manners. They raised concerns over the Crown Bank consultation and were worried about losing parking in the area. They were also concerned about the café opening up and the fact that they would be serving breakfast as this could cause an increase in traffic, in particular lorries drivers stopping for breakfast. They also raised other issues including the possibility of providing public toilets, the overflowing drains on Crown Bank and also asked whether the Goat could be made a community pub. The Clerk reported that Mrs Sale had also made contact by telephone as she had attended the surgery but nobody was there.

The next surgery to take place on 26th November. Cllr P Ryan to attend.

1096 - P/2017/01030: Yeatsall Cottage, Uttoxeter Road, Abbots Bromley, Staffordshire, WS15 3BR Retention of a panel fence and associated landscaping scheme

The Parish Council comments is as follows:- It is proposed that the new hedge will be 850mm in height and the fence is 1500mm and therefore the top section will still be visible. The PC would want to see the hedge grown to a final height whereby all of the fence is obscured.

1097 - P/2017/00621: Goats Head Market Place Abbots Bromley WS15 3BP Listed Building application for the repair of the external timber framework to the south gable

The time frame for the completion of the works is putting an historic asset at increased risk of decay, especially as we head towards the winter period. The repairs to the exterior gable end should have followed closely the repairs to the internal structure and the delays in seeking the correct permissions have been unnecessarily lengthy. 2) We have concerns that the proposed materials (lightweight rendered panels) will not be fully in-keeping with the traditional wattle and dawb techniques of the building frontage. Just because sections of the building have been repaired in the past not using these traditional methods (for example on the opposite gable) this does not mean that a fully in-keeping solution shouldn't be sought in this case. 3) The Parish Council is concerned that as custodians of an historic and listed asset Punch Taverns are not taking responsibility for ongoing care and upkeep. Abbots Bromley prides itself on the appearance of the village and has recently won the Staffordshire Best Kept Village Competition. All of the other pubs in the community have played their part by ensuring that exteriors are well kept and well maintained. The Goats Head is letting the village down by its appearance and the ongoing delays on gable end completion is making it more difficult for this part of the village to appear attractive and to entice visitors to support the rural economy. We would request that Punch Taverns rapidly follow the advice fully of ESBC and English Heritage on the gable end repairs so that the building can be properly protected before the winter period. We would also urge that other much needed painting and repairs are carried out as a matter of urgency to the exterior to fully reflect our Best Kept Village status.

1098 - P/2017/01147: Field House, Bromley Park, Parkgate Lane, Bromley Wood, Abbots Bromley, WS15 3AH Conversion and alterations of agricultural barn to form 1 residential unit, including first floor balcony, erection of a detached garage and store and extension of residential curtilage.

Received: 11/09/17 Reply due: 02/10/17 Councillors felt that the design is poor and doesn't look like a barn conversion. The size of the new garage is disproportionate and the council also questioned the increase in size of the domestic curtilage. The application also states that there is no highway, however, a footpath does pass the property.

ii. Neighbourhood Plan Update

The timetable was discussed at some length. Cllr B Walters said that really the group needs to give the Parish as much information as possible but needs to manage their expectation. It was agreed that the time for the consultation period should be lengthened until January.

Cllr B Walters confirmed that a letter had been received from Abbots Bromley School and they had contacted Punch Taverns regarding a footpath.

Cllr Walters said that on Horn Dance day a consultation was held regarding The Crown Bank area and that generally the feedback was that the village lacks a centre and that the Crown Bank could potentially be used differently. Three drawings had been created to give people an idea of what could be done, possibly to extend the pavement and give more public space. 59 forms were completed on the day and the general view was that the space could be used differently. Residents will get another opportunity to comment as part of the consultation on the Neighbourhood Plan.
