# 136. Neighbourhood Development Plan Update

Cllr Hobbs provided an updated on the Neighbourhood Plan:-

- The group is working towards writing the policies and hopefully these should be available January/February.
- The group had a meeting, along with the Parish Council, with the Woodard Corporation regarding the sale of the school. The school will primarily be marketed as an educational establishment and as a whole. They are now getting to a period where it may be marketed more widely.
- The Nuttery was discussed in the meeting and they seemed open to negotiation regarding this area.
- Woodard interested in working with the NDPG to ascertain what the housing need is.
- Maintenance on the school buildings being kept to-to-date
- Consultant to write the plan and has been provided with information and details on all consultations and meetings that have taken place in the parish.
- The NDPG is drafting the outline
- January/February there should hopefully be a draft plan
- There will be a public meeting which the Consultant will take and feedback received at that meeting will be put in to the draft plan.
- ESBC will then review the plan an then it will go to public consultation
- Nine people came to the last drop in session
- Need to achieve a greater level of engagement.
- School is probably going to be the biggest issue
- Cllr Dr Whorwood asked when the consultation period is likely to be. Cllr Hobbs said that it would most likely be end January, beginning of February.
- Councillors discussed the school. Cllr R Love thought it highly unlikely that the school
  would remain as a school as no independent schools have opened up in the last few years.
  Site expensive to redevelop but could meet needs for affordable housing
- Cllr Dr Whorwood thanked the NDPG for their work.

## i. Open Green Space

Several responses received to letters sent out by Council. Needs to be made clear what a local green space looks like. A landowner can put in an objection in. The issue can often be that members of the public are not respecting the land they are walking across. It may be necessary to send more letters to landowners. All members agreed.
