## 78. Public Session

Mr Chris Wood and Mr John Stevenson attended the meeting, represented ABSA

Mr Chris Wood - Thanks for the invite. He explained that the reason for them coming to talk to the PC as now finding it difficult to find funds for the development of the site. Amazing piece of work over the 7-8 years and so far the project has cost close to £700,000, £114,000 raised by the community. It is unfinished, the club house needs to be built, all weather

facilities that need to be put in to make me all inclusive. Finding it really difficult to find funders. Here to find out ways to support the completion as they are looking for about £350,000 to complete the project.

Mr John Stephenson explained that funders are looking for community projects so we need to know that the Parish Council is fully behind the project. He said that they had spoken to Cllr Atkins but not had much support. Melbourne, fantastic development, partnership scheme heavily weighted by the local council. Need some assistant but appreciate the assistance we have had so far from the PC and from East Staffs BC. Probably need to raise £100,000 to release match funding. Maintenance of the site is also a cost. At the moment they can't sell anything as don't currently have a club house so no income stream but still have overhead costs.

Cllr K Haywood confirmed that the Parish Council is fully supportive of ABSA. Parish Council to provide a letter of support. Cllr R Love asked if ABSA could provide something for focus to enable the Parish Council to look at possibly a loan

# 80. Minutes of Previous Meetings

**RESOLVED**: that the minutes of 26<sup>th</sup> May 2021 were signed as a true and correct record with 2 amendments.

# 81. Neighbourhood Development Plan Update

Cllr P Freeman put it to the meeting to remove Policy NGB2 – Supported by Cllr R Love, Seconded by E Rodway-Bowden. Cllr Freeman asked the Parish Council how much involvement do the Parish Council want the consultant to have. Either hand it over to him to complete or work on it as a group and then get the consultant to finalise it. Cllr R Love supported the latter as much work had already been done by Mr Wheeldon and the group. Cllr K Baker said that there was always the view that it would be to get Dave Chetwyn to chair the public meeting. Councillors discussed funding for Neighbourhood Plan and it was agreed that they would need to know what costs the council is looking at and what funds are available.

The Group to go back to ESBC to ask where their figure for affordable housing came from as there seemed to be no great evidence. Some need but there is some supply already and there will be a turnover on that.

Current providers – Trent & Dove, Beth Johnson Houses, Almshouses. The group is currently working on how many affordable housing units are available. Been back to Acon to clarify gross or net figures. They estimated 43 affordable housing units in Abbots Bromley. NDP feel that the requirement for affordable homes can be met by identified plots. Possible Face to Face meeting with Naomi Perry from ESBC to go through the figures with her. Enough information to dispute the need for 29 additional affordable houses.

Cllr Rodway-Bowden expressed reservations in selling the land. It was agreed that any sale would need to be advertised. Agreed to defer until the next meeting.
