36. Minutes of Previous Meetings

Cllr Baker highlighted that in minute No 25 Matters of Report – Welcome Pack and Visitors guide are being worked on by different members of the PC. Welcome Pack by Cllr Mrs Haywood and the Visitors Guide by Cllrs E Rodway-Bowden and K Baker.

The Clerk said that she had also received some amendments from Mr T Wheeldon to the Neighbourhood Development plan section of the meeting. The Clerk said that she was happy to accept the amendments apart from reference to the Neighbourhood Plan Website which was incorrect as this sits within the village website. Councillors agreed to accept amendments.

RESOLVED: that the minutes of meeting held on 31st March 2021 be signed as a true and correct record with above amendments.

37. Neighbourhood Development Plan Update

Cllr P Freeman provided an update. Bulletin article provided by Cllr Freeman.

Mr T Wheeldon has completed amendments as highlighted by the PC. Rebecca Raine at ESBC is helping to draft something with regards to housing needs – hopefully receive something within the next week.

Cllr Freeman commented on Local Green Spaces – digging around the decision not to pursue local green spaces, decision was to concentrate on the policies. Reference to 2019 questionnaire, there was positive and negative responses to this. Still a lot of work to do on it. In order for the local green spaces to be included in the neighbourhood plan considerable work would still need to be done. We need to consider what we can gain from including them at this stage. The green spaces inside the settlement boundary are highly unlikely to be developed. Keen to have a neighbourhood plan in place to set some parameters for developers.

Cllr Baker – brought to his attention that the government legislation isn't very robust and has been challenged by developers.

Cllr Mrs Brown – expressed concerns about not including any Green Spaces at the girl's school if you don't include the green spaces at the school then the village would have concerns.

Cllr Dr Whorwood wanted more detail in order to make an objective decision as to whether Green Spaces can be included – what can we achieve in a reasonable timeframe. Can Rebecca Raine from ESBC provide more details as to what work needs to be done. Cllr Mrs Brown said that she does have a conflict of interest. Her husband was asked if there was an intension to build on the church yard field which they had said no, they are farmers. Cllr Mrs Brown wanted to know whether the group are willing to sacrifice other green spaces such as land at the girl's school when not proving these other green spaces. Cllr Dr Whorwood said we need to be really clear that we have tried to explore all avenues, develop in some areas and protect in other areas. As long as there is a clear chain of communications and discussions and put some numbers on it at least then we have gone through it thoroughly. Leave for 17th April meeting and hopefully more input from ESBC.

39. Matters of Report

i. Welcome Pack & Visitors Guide

Cllr Mrs Haywood confirmed that she had gathered information for the Welcome Pack and was in the process of putting it together and would circulate it to councillors as soon as possible. Cllr Bake and Cllr Rodway-Bowden have been working on the visitor guide. Sorted out four possible routes for visitors to follow in the village. Need to access a map that isn't copywrited.

ii. Wildflower Planting

The Clerk confirmed that Mr McCulloch had now selected and sprayed areas where flowers would be planted but need to wait for the grass to die off before planting seeds.

iii. Tree Inspection

The Clerk confirmed that the tree inspection had now taken place and the inspectors report had been circulated to all councillors. No immediate works had been identified but general maintenance work would be required over the next 6-12 months. Councillors advised that the inspector agreed that a three yearly check would be sufficient and suggested that councillors carried out visual inspections on their way around the village eg playground inspections.

i. Recreation

The Clerk updated on repairs to the playgrounds. New seat now replaced on the duck at The Nuttery by Cllr Rodway-Bowden. Woodchip installation done on MG and new swing planned for week commencing 14th April.

ii. Village Property

Cllr Mrs Brown recommended that a village Spring Clean be arranged to coincide with The Best Kept Village campaign. Possible timing to be bank holiday weekend, 1-3rd May. Put a shout out in the Bulletin and get people to adopt an area, possible jobs to include cleaning street signs, weeding, litter picking. Cllr Whorwood expressed thanks to all those that had been litterpicking over the past few months.

iii. Traffic, Parking & Highways

Councillors discussed restarting Community Speed Watch, however, at the moment there is a lack of volunteers. The Clerk said that there may be a possibility to link with Kingstone PC and share resources and personnel. Cllr Mrs Haywood said that she would not be volunteering again and didn't believe that it would work sharing equipment across the villages. All areas for CSW need to be risk assessed so not always possible to cover all routes and roads.

RESOLVED: to utilise the Bulletin and social media to find more volunteers to be trained.

Councillors discussed possibility of gaining a grant from HS2 to cover cost of speed identification signs and gain a temporary weight restriction on the road trigger by HS2. Further research to be done on grants available and continued communication with HS2.

Councillors commented on the cars for sale on the Crown Bank. Not action at this point but noted that this had been raised.
