27. Neighbourhood Development Plan Update

Cllr Baker gave an apology for his misunderstanding regarding which document was published.

Cllr Freeman gave an update on the drop-in sessions. Nothing negative but some misconception that the plan may contain areas for development.

One more drop-in session on 5th March. Possible leaflet to be distributed prior to the next session. Councillors discussed leaflet. Cllr Lockey said that she had received the original abridged document but wasn't sure what to do with it. Cllr Love explained the process of the plan and the consultation and how people could interact and feedback. Cllr Lockey said that an executive summary would be useful and what this means to the village and what they can do and how they can feedback. Cllr Lockey said that the plan did a lot to protect the village.

Cllr Baker mentioned Gallimore's field – a lot of people asking why the plan doesn't include Gallimore's field. Cllr Beaumont asked for clarification about Gallimore's field as he didn't know the history. At the last meeting of the Village Hall Committee two residents came along and asked what the Parish Council is doing to support the development of the field and gifting of the rest of the field to the village. Originally a contract was drawn up with a 5 year term and that contract runs out in August. Need a definitive answer as to how anyone could apply for planning permission to put housing adjacent to the settlement boundary. Neighbourhood Plan can't comment on a particular plot of land. Cllr Beaumont suggested that the Village Hall Trustees should contact the landowner and the Parish Council should not be involved.
