83. Apologies for absence

Apologies received from Cllr K Baker **RESOLVED:** to accept apologies

84. Public Session

Cllr Love asked if everyone could respect each other and allow people to speak. Everyone Would get a chance to speak but keep it to 3 minutes per person.

Ms Harvey-Salmon said that she was going to be the spokesperson for the residents of Seedcroft, wanted to be transparent and Clear, non in support of the Glamping Application. There has been no direct consultation with the local residents by the applicants, despite being advised by the Parish Council. There had been suggestions that 5 caravans have been purchased.

Ms N Boyce confirmed that there had been no purchased caravans and no plans to put caravans on the site. No plans for anyone to bring caravans on to the site. Do not need to say how many tents would need to be the site. The Planning Officer advised them that they should put in an application for up to 10 shepherds huts. No suggestion of festivals, we have only mentioned food tasting and music in the afternoon and not evening events.

A parishioner said that they need to think about everyone else's families and how it will affect those that live in the area.

Ms Harvey-Salmon continued, the view will be disrupted and residents will lose their privacy. Noise on site and neighbouring houses, potential increase in crime and social disorder

Mr J Barriball stated that the planning officer has seen the space and does not believe that properties will be overlooked. Shepherds huts are for couples. A parishioner asked if issues will be policed. A parishioner said that they didn't approach the local residents. Mr J Barriball said that they put in a pre-planning application. Parishioners said that they were doing work without having applied for planning permission.

A parishioner asked how are the visitors going to get there as there have been incidents of people being abused by other road users.

A parishioners mentioned lights shining into their lounge as the parking spaces have been put near to their house. Mr Barriball more than happy to talk to them about this and happy to change this.

Parishioner mentioned the access. Mr Barriball said that Highways are looking at the suitability of the access.

Ms Harvey-Salmon said that there is potential for damage to personal property and we are aware that the site has bookings for July. She continued that the to provide high end glamping there would need to be extensive facilities.

Mr Barriball – not suggesting high end in terms of grading but as a price point and how they look, each shepherds' hut will have their own bathrooms and kitchens. Outside kitchen and bathroom will be no bigger than garden sheds. Toilets and showers will be eco and compostable. Soaks into natural soakaway.

Parishioner mentioned drainage survey being done.

Ms Harvey-Salmon said that the entrance is not suitable, lots of flooding due to water running off the field, concern on flooding in that area.

Mr Barriball said that any run off will be going the other way towards the reservoir

Parishioner raised compacting the ground with putting the rubber mattering

Ms Harvey-Salmon raised the issue of fire risk on the site. Mr Barriball said that each unit will have a fire extinguisher. No fires in the shepherds huts, no gas cooking in shepherds huts, no open flames in bell tents, tents are flame resident. Only have plans for one fire pit and looked at small chiminea with each bell tent.

A resident raised the issue of Air pollution due to fires.

Limited access for the emergency vehicles. Parishioner said that fire engines would not get through the gates.

Parishioner said that Highways raised concerns about planning application 20 years ago.

No on-site manager there all the time. Ms N Boyce said that they are in the village and contactable 24 hours a day.

A parishioner asked who will be responsible for people trespassing, SSSI Mr Barriball said that an ecological survey has already been done. Parishioner said that Natural England

Ms Harvey-Salmon asked Mel – what about food waste as they will increase vermin

Ms Boyce said that all managed in the usual way, screened and locked

Ms Harvey-Salmon asked about artificial lighting – Mr Barriball said that all low level lighting, sensors when people walking to the toilets.

Parishioner – asked if they will be seasonal – Ms Boyce said tents will be seasonal so March to October. Three shepherds huts will be all year round.

Parishioner asked why they picked a site in open fields. Another resident asked if they would like it in their back garden. Ms Boyce said that they are just trying to do their best for their family

Parishioner asked why not everyone has been given the information. Another parishioner said that it has all be done the wrong way around.

Ms Boyce said that they had to wait for surveys to be done before we could put in for change of use, we couldn't move forward. Planning had been put in but not accepted and had to provide extra information, because of data protection planning cannot give the information until the planning application is accepted.

Ms Harvey-Salmon asked if dogs would be allowed. Ms Boyce confirmed that no dog allows

A parishioner mentioned that shipping containers not in keeping – Mr Barriball these will be clad so will not look like shipping containers

Parishioner said that facilities not sufficient for the number of guests – Ms Boyce said there will be 4 bell tents.

Natalie explained how the composting system works

Parishioner asked why the site was selected

Ms Boyce explained that the Planning office will not allow a glamping site to be outside of the settlement boundary. It took a year and half to find a suitable field.

Cllr R Love clarified how the planning application will be dealt with and that the Parish Council will consider comments and then respond to ESBC.

Richard asked if the questions raised could be sent to Poppy Fields so that they can be responded as a Q & A

Parishioner asked if the toilets are going to be professionally made. Ms Boyce said that yes they are done professionally.

Richard Love said that they public session will be closed.
