97. Public Session

Cllr R Love welcomed the Borough Councillors

Mr T Wheeldon as if at future meetings consideration could be given to remembrance parades, potential utilisation of the funds held for restoration of the War Memorial.

Cllr Love said how fantastic the bench looks on the Green that has been placed by The Barker family

Representatives from Seedcroft Lane said thank you for listening to us at the last meeting and thank you for all your support. You controlled the meeting very well and listened to both parties well. Cllr Love said that it was a difficult and immotive topic. Our views have been reported back to ESBC.

Mr Walters asked for clarity on the next steps on the Neighbourhood Plan, little bit unclear. At the meeting I requested that the full report be published. Minutes state that Mr Dave Chetwyn stated that the full report shouldn't be published. Simple question, are you or are you not committed to publishing a full report?

Cllr Love clarified that Dave Chetwyn is the Parish Council's consultant from Urban Vision. Cllr Love explained that many of the responses were incorporated into the plan. Mr Chetwyn said that it was wrong to publish all the responses but to incorporate the

responses. We were given different advice, we had thought he was fine but he had advised that it is not part of the process.

Mr Walters said that he wanted clarification.

Cllr Freeman said that at the meeting on 18th May that we were all in agreement that there is no harm in publishing the redacted responses. Mr Chetwyn was adamant that the full report shouldn't be published at this stage and it had to go through the due process. Mr Walters said he would quite like to understand why the consultant would advise that. Cllr Freeman said that it is part of the remit of ESBC.

Mr Walters said that with regard to the school site he doesn't feel that the policies in the NDP will be robust enough. Ask the PC to work with Friels, extremely important to work with the developer. It is important that we all get something from the scheme.

Cllr Beaumont said that because it has taken years to produce the NDP so it hasn't yet been published so cannot be used as leverage.

Mr Walters said that a draft can still hold weight. Developer will have their own ideas on what they want to put on the site.

Cllr Love said that the early conversations that we have had with Friel have been positive. Dialogue with Friel homes will not alter from what the community wants. Aim is to meet in the middle. Our aim was to get a policy for any development.

Mr Walters said that the developer may come with offers and the PC need to be mindful of that. If the community can get some tangible results.

Cllr Love said there will be conversations with Friel.

Cllr Baker, my understand is that the draft plan does have some weight. Mr Walters said that yes it carries a certain amount of weight but when it goes through the full process then it will carry more weight.

Cllr Vicky Gould – Stretton Ward (chair of planning) introduced herself. Boundary review has formed a much larger Ward. Want to make sure that the Village has a link back in to the Council. Cllr Bev Ashcroft (also on planning) said she wanted to put a face to a name and come to more meetings. Third Councillor who isn't here isn't on planning. Can put forward for pots of funding, neighbourhood funding. Community Grant available, as long as community project.

Cllr Brown mentioned ABSA struggling to gain funds. Borough Councillors said that it would need to be something specific but they can pay towards something.

Cllr Love asked if it has to be capital costs or can it be for legal fees etc. Borough Councillors said that they believed it would only be something tangible.

Cllr Love thanked the Borough Councillors for attending.

Clerk raised issue of being passed from pillar to post by ESBC, issues with allotment, parking issues, who deals with issues with Parking.
